### **Due Diligence Processes**

West Advanced Technologies Limited adopts a diligent approach to managing the risks associated with modern slavery and human trafficking within our supply chain. We prioritize transparency and accountability in our commitment to combatting these issues, both internally and externally.

To ensure our commitment is known and adhered to, we publicly communicate our stance on modern slavery and human trafficking via our official channels, including our website. Internally, all employees are required to abide by our policies, which emphasize our zero-tolerance approach to modern slavery and human trafficking. We are also in the process of implementing contractual requirements for all suppliers to explicitly state their commitment to these principles in their agreements with West Advanced Technologies.

In our supplier screening processes, we integrate considerations of modern slavery risks from the outset. Initial screenings include discussions on responsible business practices, including compliance with applicable laws and adherence to our Responsible Supply Chain Principles. These principles serve as a foundational framework for ethical conduct in our supply chain relationships.

For our largest suppliers by spend, we conduct corporate responsibility screenings to assess their commitment to ethical business practices, including their stance on modern slavery and human trafficking. Additionally, we regularly survey our suppliers to gauge their understanding of and compliance with our expectations.

Considering the nature of our procurement activities, which primarily involve skilled services such as enterprise applications and digital transformation solutions, we assess the risk of modern slavery to be low. These activities typically require specialized knowledge and expertise, reducing the likelihood of exploitation within our supply chain. Nonetheless, we remain vigilant and proactive in identifying and mitigating any potential risks.

At West Advanced Technologies, we are committed to upholding the highest ethical standards and ensuring that our supply chain reflects these values. ### **Risk Management**

To evaluate modern slavery risks within our operations and supply chains, we conduct regular assessments, considering both internal and external factors. This assessment involves identifying strategic suppliers and analysing actual and potential risk factors associated with supplier location, commodity, manufacturing type, and sector. Factors such as country risk profiles, industry standards, and audit results are considered to determine the level of risk.

We recognize that certain groups, such as migrant workers, contract workers, and vulnerable populations, are particularly susceptible to modern slavery. As part of our risk assessment, we prioritize identifying and addressing risks associated with these vulnerable groups. Additionally, we acknowledge that some countries present higher risks for modern slavery due to factors like weak labour law enforcement and prevalence of exploitative practices.

To mitigate supply chain risks, we conduct thorough audits of prospective suppliers, particularly those identified as high-risk. These audits include on-site inspections, interviews with management and workers, and reviews of relevant documentation. Identified issues are promptly investigated, and corrective action plans are developed in collaboration with the supplier.

Within our organization, we have implemented robust systems to identify and address potential modern slavery risks. These include regular record analysis, red flag identification, and reporting mechanisms for concerns. We also provide support to whistleblowers through a confidential helpline, fostering a culture of accountability and transparency.

Furthermore, we actively engage with industry organizations such as the Association of Labour Providers (ALP) and Stronger Together to strengthen our processes and enhance our ability to prevent and detect modern slavery concerns.
